3. I willingly agree to comply with the stated and customary terms and conditions for participation. If I observe any unusual and significant concern for my readiness for participation and or for the activity itself, I will remove myself from participation and bring such to the attention of the nearest officials immediately, and,
4. I, for myself and on behalf of my/our heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE the J-Six Ranch Equestrian Center LLC and/or WickedGood Horsemanship LLC their officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the activities ("RELEASEES") WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property incident to my involvement in these activities. WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I, for myself or on behalf of my/our heirs, assigns, personal representatives, and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all of the above Releasees from any and all liabilities incident to my or my child(ren)*'s involvement or participation in these activities, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent of the law. I agree that J-Six Ranch Equestrian Center makes no claims as to the safety and suitability of the surface and sub-surface footing conditions or hazards and conditions of the terrain whether visible or hidden or obscured by vegetation.
